And now I who am brought into this matter my name was that's been spoken about. Now I have got to answer for myself,

Because when our speaks some would say but what does Reverend Stegen say about this?

He said, Let me leave the dead burying the dead.

Marius Pretorius 15:08

And then he said, leave it for now until he moves. And then you move

Marius Pretorius 15:21

they came the day before yesterday,

Marius Pretorius 15:28

and then I said speak,

Marius Pretorius 15:35

That's why I will speak. And then my brother will speak

Marius Pretorius 15:47

there are so many things that you've read on the internet.

Marius Pretorius 16:05

and I haven't read it on the internet but the many things that have been passed on to me and I haven't been able to respond to any of those allegations and accusations,

But I have gone to those who might have been able to those who are the actual people that are saying certain things. And I've even said you go and speak to your father who is saying this and that about me

I wasn't alone. I was together with Aunt Eunice

Marius Pretorius 17:16

She's not here. She's not well, but where she is she can see me and she can follow

And I say leave it because you don't come to me. And you don't ask me about any of this. Of what you just spoken

and then I said are now I'm satisfied that you've done it.

when I did that, apparently I worked secretly.

Marius Pretorius 18:31

Sorry, I worked according to our Zulu customer.

Marius Pretorius 18:43

Now, according to our Zulu custom, as a child, you cannot go and attack an older person.

Marius Pretorius 18:57

you need to send the oldest person either the oldest son or the oldest daughter to go on your behalf.

Marius Pretorius 19:06

and that's what I did.

Marius Pretorius 19:10

and it was taken lightly.

Marius Pretorius 19:16

And I was brought an answer. And we said here it is.

Marius Pretorius 19:24

Now This started a long time ago.

Marius Pretorius 19:38

In 1991 And then there's something that you may have you heard about in the year 2000.

Marius Pretorius 19:49

And those days, those who have my own skin color. They were the ones who are red hot on fire.

Marius Pretorius 20:06

And 1994, we had the democratic elections after which we had the first black president.

Marius Pretorius 20:19

And we also were active fighting during that time, and fighting a battle. And then we were known for what we were we were doing we got, we became known,

and then in the year 2002, I stood here in front, and I said, I'm sorry, I apologize for everything that you heard about me.

But we said, you know, let's leave them for the time being, let's just deal with those of our own color.

And they thought, well, they had got away with it. I noticed because we didn't expose them or deal with them.

Marius Pretorius 22:30

And at that time, I was actually not at the mission, because it was said that I had lied and deceived. And for that reason, I wasn't here. And then uncle Friedel Stegen went to fetch me where I was. And he pleaded with me to come back. And he brought me to his own home.

and then he gave different reasons and say different things. And I said, Well, should I then go with you

Marius Pretorius 23:14

And he said, Yes, indeed. You will stay in my house. And that's what happened.

Marius Pretorius 23:25

and I lived there for a couple of months.

Marius Pretorius 23:43

And then a team came and say, Please, you know, we have forgiven you of what you've done. And we also would like to ask you for forgiveness. So please come now, and be with us. Okay.

And so, I then returned and I was in the work again

Marius Pretorius 24:20

And then I said to Rev Stegen and there's something that has been revealed to me

Marius Pretorius 24:33

I said Rev Stegen and mothers. There is something that's been revealed to me

and they asked and said what?

Marius Pretorius 25:19

It's been revealed to me that I should go to the street corners and invite those who are sitting on the street corners to come to the feast because the table has been laid. The feast has been prepared, but there is no one to partake of the feast.

And then I went back to the Rev Stegen and I said Mr. Sibisi answered this is what he said.

Reverend Stegen said Thofosi calling me by my name, he said I support you in this leave them forget about him.

Marius Pretorius 26:59

and said I'll give you a vehicle vehicles and you can go and do this work.

Marius Pretorius 27:13

And then we did that we went out and we distributed these pamphlets 2003

Marius Pretorius 27:52

I then heard there were some talk that CFT. there are people that want to hijack CFT so we went in we had a meeting at Mr Sibisi's place and we spoke about those allegations that no meeting should be held outside because people want to hijack CFT

Marius Pretorius 28:17

So we made the uncle Friedel's place

Marius Pretorius 28:27

And then uncle Friedel said it should be closed down. and we said no. Why must it be closed down because we only want to do this. That's good.

Marius Pretorius 28:53

and then he said no, CFT is like a vehicle that's run out of steam. And then CFT was closed down. And I wasn't in that. That was something that they decided

Marius Pretorius 29:17

But after that, then I heard will say no, Thofози closed it. I don't know if it was Mr. Bosman or whether it was Arno's father, who it was that actually said that.

Marius Pretorius 29:43

because they in Europe, they did continue with it. But here, in South Africa CFT was closed

Marius Pretorius 29:56

and that's something that is being said and spread that Thofози closed CFT

Marius Pretorius 30:12

and then when I was unhappy about that it was said that I had done it was said just keep Be quiet just close your mouth and just look

Marius Pretorius 30:34

I'm so sorry. Because today I can no longer say Baba Maphumulo, from today on it is Nkozana Maphumulo

Marius Pretorius 30:58

Because I called him my father because he worked with Reverend Stegen

Marius Pretorius 31:12

Rev Stegen spent a lot of time in Namibia. Continuing with the work,

Marius Pretorius 31:25

and then he was unwell and he had to go to a hospital.

Marius Pretorius 31:40

and then we say you know let's just leave him let's not trouble him with issues pertaining to the mission let him just recover before we inform him.

Marius Pretorius 31:58

and just these days on a Sunday he found at nine o'clock and evening

Marius Pretorius 32:09

and he said yeah Thozozi and said why did you chase Arno away from the mission

Marius Pretorius 32:22

Because he revealed you and Jabulani that you've chased him away?

Marius Pretorius 32:32

And I said Baba Reverend is that what is being said? Was that what Arno say?

Marius Pretorius 32:53

And I said how come they actually come to you to say this to you? Because they say that your mind isn't functioning well anymore? You confused?

Marius Pretorius 33:14

and he said tomorrow at nine I want you to be here because this is what came to me and I've asked him to be here as well. Okay so we met and then I noticed that Arno's wife wasn't there and I said that doesn't seem right to me. She ought to be here as well.

Marius Pretorius 33:49

So we started

Marius Pretorius 33:57

that this was said that I say to Arno take your bags and leave

Marius Pretorius 34:11

then he said no Rev Stegen didn't understand him correctly. So what did I then say to you? And then you went this way and that way. And then his wife said Hang on. Arno. You told me when we were at Franshoek that we are leaving the mission

Marius Pretorius 34:49

and that's we continued. And we spoke

Marius Pretorius 35:03

I'll tell you about the gifts that I've been given

Marius Pretorius 35:11

number one I'm a Satanist

Marius Pretorius 35:24

all those who pray together with me they are in full influence and they become Satanists. Don't come and pray with me because that's going to enter you

Marius Pretorius 35:52

I've got a witch doctor that comes and visits me at half past 2 at night and then now actually aunt Eunice she is the one who gives me witchcraft medicine.

Marius Pretorius 36:23

So where does the witch doctor come from?

Marius Pretorius 36:29

and then they say

Marius Pretorius 36:35

and if you ask them already if he indeed is a Witch Doctor No I said no please feel free to ask the witch doctor.

Marius Pretorius 36:53

They speak about my own very cousin

Marius Pretorius 37:08

so why don't you tell him because if I speak to him then maybe you say I will influencing

Marius Pretorius 37:21

but it's the story has even reached him now on its own accord

Marius Pretorius 37:53

these rumors they just spread like wildfire.

Marius Pretorius 38:13

And then it says I've joined the ANC

Marius Pretorius 38:23

I'm working together with Zuma.

Marius Pretorius 38:30

he saw me involved with him

Marius Pretorius 38:43

because you know that's effect that we mentioned as effect so they can actually follow up on it and go and actually look in the ANC records in the all the offices and see if my name is on any of the books Oh, what about Inkhata

Marius Pretorius 39:13

I said well, you know you can go and do research and all of that and find out whether it's true because those are you mentioning things that should be concrete facts.

Marius Pretorius 39:27

and it's said that I steal money at the mission or steal the missions money

Marius Pretorius 39:39

and I said. Arno. who has the authority to sign checks at the Mission

Marius Pretorius 39:48

who speaks to the mission auditors

Marius Pretorius 40:10

And I said, Look, you know, all of those are things that one can go into and really find out. Is there any truth in that, and I said, I can give you my bank statements for so many months back cause for as long back as you want. And as you can look at my bank statement,

Marius Pretorius 40:40

And then it is said now, because Reverend Stegen doesn't know what he's doing. He is off his mind. He's got dementia. So you just bring something to him to sign. And he signs it, not knowing what he's signing?

Marius Pretorius 41:04

And then he just signed something he doesn't know what he's signing for. And then that money gets sent and Arno is a witness to that. I say that's good, because you're a witness.

Marius Pretorius 41:21

And then you can say where does Thozozi comes into this.

Marius Pretorius 41:29

I said, You are the ones that started accusing me.

Marius Pretorius 41:38

I said, let's speak about this now and you're not saying anything.

Marius Pretorius 41:48

And so now even people outside know about this, and they are the ones that push that I should come and speak to you.

Marius Pretorius 42:19

No money goes out of the mission, unless it's authorized by the director. And those

Marius Pretorius 42:29

and those who are the directors or the trustees of the mission.

Marius Pretorius 42:41

because we are a trust and we've got trustees

Marius Pretorius 42:49

no money that goes out unless it's known by them.

Marius Pretorius 42:57

There is no money that Reverend Stegen stole from the mission.

Marius Pretorius 43:08

and they know about all the money is spent that is spent because they are at that meeting where it gets decided.

Marius Pretorius 43:34

Uncle Friedel cannot sign anymore because he's not well, so his son signs on his behalf. But I don't have any authority to sign there. I sign other things on behalf of mission

Marius Pretorius 44:01

So when money goes out of the mission, it is authorized by them under their names - Arno and his father.

Marius Pretorius 44:20

There is no offshore account that Reverend Stegen has

Marius Pretorius 44:37

offshore which means somewhere else on an island or overseas in a foreign country.

Marius Pretorius 45:02

but it's a no they are some offshore accounts, maybe in Iceland or I don't know where? Well if that's when that money can be fetched back let's find it

Marius Pretorius 45:25

now according to by their signatures. The mission has been removed the overseas branches have been removed from Reverend Stegen, by the authority of their signatures. Do you hear that? Did you hear that. I'm glad that some Europeans that are here

Marius Pretorius 46:00

I think you can testify to that, isn't it? So?

Marius Pretorius 46:13

This from Jan from Holland, the Netherlands. The others from Switzerland Germany and I'm sure they could also testify to that

Marius Pretorius 46:31

now where they really stepped onto it is here with us here in South Africa

Marius Pretorius 46:44

now pertaining now to the mission here. Here, it's in South Africa this mission.

Marius Pretorius 46:59

In Malelane many are busy packing their bags they say they leaving. You hear that. Now we won't allow it

Marius Pretorius 47:18

well, if they want to do whatever they like they're in their place as well. That's up to them. That is their matter

Marius Pretorius 47:31

it's just so sad because even Rev Stegen's signature is forged.

Marius Pretorius 47:52

Now, I wouldn't have spoken about this. But my name is in the forefront in all of these things that are spoken, so I'm just clearing my own name.

Marius Pretorius 48:17

And because my name is mentioned, so therefore I've got to mention other names as well.

Marius Pretorius 48:29

And he said these boys who come here.

Marius Pretorius 48:35

I've spoken to them

Marius Pretorius 48:44

There are some that have left because they've been deceived by this team

Marius Pretorius 49:11

And I said now you mustn't be quiet because they say you are working for me. I've got a drug factory

Marius Pretorius 49:34

that you are aware of that factory. Well, I said, Well, please bring any evidence with regards to it. Let it be brought into the open, where is it?

Marius Pretorius 49:52

and we know who you are talking to.

Marius Pretorius 50:00

Come on say now you sorry

Marius Pretorius 50:10

and those who came and spoke to me and asked me, I explained to them and I forgave them

Marius Pretorius 50:23

there's a big problem that you whites have

Marius Pretorius 50:29

because you've got big ears where everything comes in

Marius Pretorius 50:39

But you only hear from the one side you don't want your other ear to work as well.

Marius Pretorius 51:01

there is I know the older name or the previous name, which was known as Lizette in the way that she has really smeared my name

Marius Pretorius 51:17

that I've got a list of Satanists.

Marius Pretorius 51:26

So you've got proof of that isn't it so, because she's spoken. So there must be proof of it.

Marius Pretorius 51:35

put it on the table.

Marius Pretorius 52:04

so I ever use the Lord's up to me. Because if people come to me, and I say, you know this, isn't this what I've heard of you, I can respond. I can say no, this is the truth. But the person believed the lie.

Marius Pretorius 52:26

I still respect Reverend Stegen as the leader of the mission.

Marius Pretorius 52:38

And he started this work, all alone. And I was part of that generation when he started even before I was born

Marius Pretorius 52:57

And then 50s. He started already with his ministry, but I got to know him in 1963.

Marius Pretorius 53:10

and that he got ahold of me. I don't know how that worked.

Marius Pretorius 53:19

all that. People say that now Thofosi is leading him by the nose, how that would be possible and how that would happen. I don't know.

Marius Pretorius 53:36

my mother met him in 1963 when he came to my Mapumulo to pitch the evangelistic tent there.

Marius Pretorius 53:50

And we grew up as Christians in the Lutheran denomination.

Marius Pretorius 54:02

My mother was in charge of the youth at the church at the Lutheran church.

Marius Pretorius 54:13

My dad was a deacon in the congregation in the church in the Lutheran church

Marius Pretorius 54:23

now you've heard my history, my background.

Marius Pretorius 54:38

And my dad they just bore with him because he would get drunk after the service on the Sunday you wouldn't be drunk in the service

Marius Pretorius 55:04

And so you would even be under the influence of alcohol and administer the Lord's Supper in the church, but at least not bring any disgrace. They do it decently, and then he would say now you go home after the church after church, you say you go home and then you'd get properly drunk, with nobody there to observe him,

Marius Pretorius 55:33

Now I want you to take note of this day this day is the day when we remember the ascension of our Lord.

Marius Pretorius 55:48

and I want this day to have historical significance because of the Lord's ascension

Marius Pretorius 55:59

at the three o'clock service at Kwa Sizabantu. I said. Eunice and the relatives. They hear me

Marius Pretorius 56:31

because they said now you must speak that's why I'm here.

Marius Pretorius 56:43

When last did you see me coming to the service?

Marius Pretorius 57:00

My dad later on, got converted and repented in 1970

Marius Pretorius 57:12

and then the 16th of February 1990. He passed away and he was buried here

Marius Pretorius 57:27

My mother got converted in 1963.

Marius Pretorius 57:41

she passed away on the 30th of November in 2010

Marius Pretorius 57:53

and on the fifth of December she was buried here

Marius Pretorius 58:00

I'm just giving those historical facts to you that you should know

Marius Pretorius 58:07

I'm also one who expects to be buried here

Marius Pretorius 58:15

I don't want to go and die somewhere outside I would like to die here where my parents died and were buried

Marius Pretorius 58:40

They are many of our family who are buried here if I count them I think they're about 13 were buried here on the mission

Marius Pretorius 58:59

my mother's father and my father and so on and so on.

Marius Pretorius 59:24

I then I'm so disappointed or sad someone wrote to me and I say these sins are being broadcasted over the internet and they even if it's not exactly but it is things pertaining to or similar to what they did

Marius Pretorius 59:59

That's what Peet Botha does

Marius Pretorius 1:00:13

and he was chased away from America. And then he came back here as a devil with two horns.

Marius Pretorius 1:00:26

you can go and tell him that

Marius Pretorius 1:00:59

and I say, you know, when people confess their sin, it's done. It's done in confidence. It's done in privacy, you confess it there and it stays in ends there, unless there is some matter that needs to be dealt with further and then that is treated in the appropriate manner. How can we help this person with this problem?

now the first group that opposed the work of Reverend Stegen

Marius Pretorius 1:01:49

It was Erwin Redinger and he really also spoke evil of my mother. And he also posted it on the internet

Marius Pretorius 1:02:02

My mother has really been slandered and smeared.

Marius Pretorius 1:02:15

and my mother actually was born into royalty. Her mother's brother is from

Marius Pretorius 1:02:30

So they are born in the Ngubane a royal family

Marius Pretorius 1:02:44

and she was able to handle matters in a very discreet manner she would say you know it's not the right time now to speak or to act just take note of what is being said and recorded and keep note of it

Marius Pretorius 1:03:22

I'm from the Dube family my father's side and we are also from that side from royalty but our royal families or the way they've got authority is more on the other side of the Tugela, Mpangeni, Richards Bay and so on and for certain reasons we ended up here towards Stanger and I won't go into those details now

And then so we first of all, deal with things according to the church. And thereafter we take it to those on authority over us and we say, you know this is what is being said of me. How must I handle this matter now?

And as I'm speaking here, I'm doing it because they said go ahead

Marius Pretorius 1:04:40

it's no longer something that we can just speak about in the family as family matters.

Marius Pretorius 1:04:49

and I went to I went to Rev Stegen and laid the matter before him just exactly as it is

Marius Pretorius 1:05:05

And I said please allow me to stand at your pulpit and say and he said go

Marius Pretorius 1:05:20

you can ask him if it's true

Marius Pretorius 1:05:27

you know we black we Africans we have this custom

Marius Pretorius 1:05:38

don't get frightened don't get a shock if we come in this manner to you because we want righteousness to succeed.

Marius Pretorius 1:06:08

And we will learn we were taught that also in the faith that if somebody said something about you hear that somebody said something about you, you go to that person and say, Is it true? That's what you said. And then the matter sorted out

Marius Pretorius 1:06:26

so we've done on that level, we've done all of that.

Marius Pretorius 1:06:39

But you whites, you hear something? And then you just got to discuss it all over. Without ever having come to me to ask about it.

Marius Pretorius 1:06:57

so you've judged and condemned yourself because you haven't asked me

Marius Pretorius 1:07:05

because of that, because they have been infiltrated by that spirit of the blacks. They shouldn't even attend a funeral.

but maybe that person has already apologized to the children for saying maybe but that person never apologized to me but doesn't come to the funeral because

may be they apologize to the children but I still know it as that.

but all of them have now formed one Alliance and they all have been brought together in an alliance as a fighting against the mission

well, you know, that's how I'm accused

So now I have to lock the doors

and then Kobus du Preez followed and he came with his own stories

Now here at the mission. We don't allow people to wear T shirts with political slogans or supporting a political party because that we bring the division

When we do vote, we do vote we don't vote because we supporting a political party per se. But because we look at the different parties we see way will my faith be better protected and that I can continue with my faith.

and we also encourage people to go and vote that they would have some say in the governance of the country

and I also voted

And those are voted for they can also say well they as Lydia, she is a citizen of South Africa. And she also used her vote. Now to the whites we don't speak about skin color here. That's not important to us at the mission.

and if there is anybody like that, then let that person leave. And that those who remain speak about Jesus. Because we were brought together by Jesus here.

Marius Pretorius 1:16:31

And if there are any Satanists in our midst, well then you better get away as quickly as you can before we go and report your reception

and you know say now I'm a Satanist and the other Satanists and me well you know I've got nothing to do with it

if you are a Satanist that have come to repent well then you are allowed here because this is a mission

Marius Pretorius 1:17:27

they you're given some time of grace where you can make right your life and you've got to go through that conversion process but if you don't well we say please make room for others.

we are the last blacks or Africans would ever consider to rise up against Reverend Stegen

Marius Pretorius 1:18:22

Reverend Stegen came. He lived amongst us he lived amongst our people to such an extent we even forgot that he was a white man.

Marius Pretorius 1:18:43

But now, if you come and you say oh, this person is an Indian, that person is a Colored that's a white that's a black. It's something that we don't know.

Marius Pretorius 1:18:56

and it doesn't go along with the mission and our conduct and our principles and values

Marius Pretorius 1:19:08

Now, the history of the Zulu nation says

Marius Pretorius 1:19:16

that King Shaka never killed one white man

Marius Pretorius 1:19:29

There are many other nations against which he fought to try and forge one Zulu Nation.

Marius Pretorius 1:19:46

and any Zulu who would fight against a white person or go against a white person at that time was said you're not a true Zulu

Marius Pretorius 1:20:01

because according to the history of the Zulu Nation, that didn't fight against the whites and I'm telling you even now, that principle still stands in the Zulu Nation

a true Zulu would say, let us sit down at the negotiation table. Let's speak

the person who speaks through the barrel of a gun, we don't know him.

And then they would say now you know, if you are like that you are of a mixed race. You're not a true Zulu.
